

**From the Newtown Township 2022 Fee Schedule:**

**PART 9 PARKS AND RECREATION**

**1. RECREATION FEES\***

\*Unless otherwise noted below, fees for Township sponsored recreational programs shall be established by the Parks and Recreation Department. Non-residents will pay 20% additional to participate in recreation programs costing \$200 or less. Non-residents participating in programs costing more than \$200 will pay 15% additional.

**2. FIELD AND FACILITY RESERVATION AND USE**

Seasons: Spring – April 1 to July 31; Fall – August 1 to November 30

**NOTE:** Certificate of Insurance naming Newtown Township as the certificate holder is required for field/ pavilion use by all organizations and companies. All sporting groups must submit the following along with application:

1. Current season's league fees and registration information.
2. Current season's practice and game schedules two weeks within initial use of the facilities.
3. Current season's rosters' complete with names and addresses within two weeks of the initial use of the facilities.
4. Board of Directors information (phone/address/email), if not already submitted.
5. By-Laws/Rules and Regulations of organization, if not already submitted.
6. Certificate of Insurance for each sport sponsored must be on file at the Township Recreation office prior to any usage. Approval will not be granted until certification is received.
7. Fees - application fee must be paid with application, player fees must be paid within two weeks of the initial use of the facilities.

Senior Groups (Age 55+)

Application Fee \$50.00/Per Season

Non-Resident Fee \$7.00 Per Person/Per Season

**Pavilion Rental**

Resident Fee \$30/per hour; Non-Resident Fee \$40/per hour

**Athletic Field Reservations**

Application Fee \$50.00

Resident \$60.00 per field/weekday; \$120 per field/weekend

Non-Resident \$120 per field/weekday; \$230 per field/weekend

Security Deposit - Resident \$120 per field

Security Deposit - Non Resident \$550 per field

\*Holidays are charged as weekend rates\*

**Tournaments (Non-Profits)**

Application Fee \$ 50.00 Per Tournament

Resident Fee \$550.00 Per Tournament; Non-Resident Fee \$850.00 Per Tournament

Security Deposit - Resident \$300.00 Per Tournament

Security Deposit-Non-Resident \$575.00 Per Tournament

**Tournaments (For-Profit)**

Application Fee \$ 50.00 Per Tournament

Resident Fee \$500.00 Per Tournament/per day; Non-Resident Fee \$900.00 Per Tournament/per day

Security Deposit - Resident \$275.00 Per Tournament

Security Deposit-Non-Resident \$550.00 Per Tournament

**NOTE:** Sponsors of any gatherings, which require police, maintenance, or other personnel and/or equipment, shall be responsible for all additional associated costs as determined by the Township. Organizations running tournaments will be responsible for providing their own supplies (toilet paper, paper towels, etc.) A deposit to guarantee payment may be required by the Township and posted with the Township prior to permit issuance.

A Certificate of Insurance naming Newtown Township as the certificate holder is required for field/pavilion use by all organizations and companies. Completed Waiver and Insurance Requirements Forms are also required.

### 3. RECREATION/OPEN SPACE CONTRIBUTIONS

#### RESIDENTIAL

Dedication of 3,000 square feet of land per dwelling unit, or  
Fee-In-Lieu of land dedication per residential dwelling unit  
\$8,070.31

#### NON-RESIDENTIAL

Dedication of 750 square feet of land per 1,000 square feet of building area, or  
Fee-In-Lieu of land dedication per 1,000 square feet of non-residential building area or  
portion thereof  
\$2,017.19

NOTE: All development plans are reviewed by the Parks and Recreation Board. The Parks and Recreation Board shall make recommendations to the Board of Supervisors as to whether the land dedication or Fee-In-Lieu is in the Township's best interest.
